- Not blocking any heaters
- Working with suppliers who are aligned with our energy policy
- Communicating energy requirements and expectations to employees
- Ensuring that employees are competent to carry out the task
- Ensuring that all necessary industry standards are met
- Seeking to use new, innovative solutions
- Sharing any good practices or areas for improvement
